

PAINTBALL PARTICIPANT AGREEMENT for "TIG"

In consideration of **Thrive Investment Group, LLC ("TIG")** allowing me to participate and/or be present as a player, spectator, referee, and field personnel, photographer, contractor or other participant in its paintball and/or self defense educational events ("event") occurring on (date) June 24th,25th,26th 2019 furnishing to me services, equipment, access and/or other good and valuable consideration in connection with the activity, receipt of which I hereby acknowledge, I hereby agree as follows:

I _____, on behalf of myself, my personal representatives and my heirs, hereby voluntarily and irrevocably release, waiver, discharge, hold harmless, defend, indemnify and covenant not to sue "TIG", its owners, members, agents, managers, officers, employees, subsidiaries, vendors sponsors, advertisers, contractors, lessors of premises and successors and assigns (collectively, the "Releases") from any and all claims, actions or losses for personal injury, property damage, wrongful death, loss of services, economic loss, rights of privacy or publicity, medical expenses or otherwise which may arise out of my participation in and/or presence at the Event and/or use of any equipment, whether due to my own actions or the actions of any third party. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct of the Releases.

_____ By my participation in and/or presence at the Event and/or use of equipment, I hereby voluntarily assume all risks and dangers and accept all responsibility for any injuries, losses or damages of any kind to me or caused by me, including my death. I fully understand and acknowledge that:

- (A) paintball / self defense education involves potentially hazardous and dangerous activities and that I am likely (intentionally or unintentionally) to be exposed to hazardous and dangerous conditions;
- (B) my participation in and/or presence at the Event and/or use of any equipment may result in my injury, illness or death, including but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, eye injury, blindness, permanent disability, heat stroke, heart attack or other ailments that could cause serious disability; and
- (C) these risks and dangers may be caused, in whole or in part, by (1) the negligence or other conduct of "TIG", its owners, members, agents, managers, officers, employees, subsidiaries, vendors, sponsors, advertisers, contractors, and/or lessors of premises, (2) Event participants, spectators, or any other person or entity, (3) accidents, (4) breaches of contract, (5) forces of nature, or (6) other causes, whether or not foreseeable.

MEDICAL PERMISSION AUTHORIZATION

_____ I authorize "TIG" to provide emergency medical treatment to me as may be deemed necessary by "TIG". If I am of minority age, my undersigned parent or guardian hereby gives permission for "TIG" to authorize emergency medical treatment as may be deemed necessary for me while participating in the Event.

MEDIA LICENSE AUTHORIZATION

_____ I hereby grant to "TIG" the irrevocable, worldwide, perpetual and exclusive right and license to photograph, videotape, film, and/or record me, and use my name, likeness, voice, biography, all of my activities in connection with the Event (collectively, the "Material"), in: (A) the Tournament; (B) all forms of media now known or hereafter existing including: without limitation, television, motion pictures, internet/web casting, publishing, videocassette/DVDs, and all ancillary and subsidiary rights therein (collectively referred to as the "Program"); and (C) all advertising, promotion, marketing, merchandising, production, distribution and other exploitation of the "TIG", the Event and Program. I acknowledge and agree that "TIG" shall own in perpetuity throughout the world all copyrights, including, without limitation, all renewals and/or extensions thereof, in and to the activity, Program and Material.

This Release And Waiver Of Liability And Grant Of Media License ("Release"): (A) shall be governed by Colorado law; (B) shall be binding upon me, my successors and assigns, and (C) cannot be amended or modified without a writing signed by me and "TIG". I hereby consent to the exclusive jurisdiction of the state and federal courts of the State of Colorado in San Miguel County over any action, suit or proceeding arising out of or relating to this Release and/or the activity. In the event of a dispute arising out of or relating to this Release and/or the activity, my remedies, if any, shall be limited to an action at law for reimbursement of entry fee (excluding any incidental, consequential, special or punitive damages). I shall not be entitled to terminate or rescind this Release, or seek an injunction or other equitable relief. **_____ I HAVE READ AND UNDERSTAND THE ABOVE.**
